## **Terms and Conditions:**

- 1. There is no entry fee.
- 2. Only one entry will be allowed per person.
- 3. Messages with all details duly filled in will only will be eligible.
- 4. Incomplete entries shall stand rejected.

## **GENERAL RULES:**

- 27. Persons interested in participating in the contest must be must be a citizen of India (as per The Citizenship Act, 1955) and must be residing in India.
- 28. Persons wishing to participate in the contest should not have criminal conviction, any pending litigation or arbitration against him/her or any arrangement or contract that prevents or restricts such person from participating in the contest or abiding with the rules and regulations of the contest.
- 29. The Participant shall execute all documents directly related to the Contest as required by the Sponsor and such documents shall be valid and binding on the Participant at all times. Refusal to execute any required documentation shall be grounds for immediate disqualification from participation in the contest.
- 30. By participating in the contest, it shall be deemed that the Participant has waived his/her right to raise any dispute of any nature whatsoever with regard to and /or in connection to the participation in the contest by the Participant and/or by the friend chosen by the Participant to accompany him/her in the event of winning the contest.

- 34. - 35. Employees of the Sponsor, employees of the vendors/agencies associated with Godrej, consultants and/or persons hired on contract by Sponsor, and members of their immediate family are ineligible for participating in the contest.

  - d. Violation of any local, city, state or central laws, rules or regulations; or bye-laws
  - e. Entering into any personal, social, business, and/or financial relationship with any other Participant, any relative or social or business acquaintance of a Participant, any employee, agent or representative of the Sponsor or any of their respective affiliates, such that the outcome of the contest is affected in any manner, including, without limitation, any arrangements for financial benefit of the Participant or any third party;
  - f. Failing to disclose information or providing false information to Sponsor or causing false information to be provided or cause any act which is fraudulent for participation in the contest.
- 38. The Sponsor is in no manner whatsoever responsible and/or shall not be held liable in any manner whatsoever, for any damage, loss, injury, death, mental trauma caused to the winner in any manner whatsoever or for any reason whatsoever in connection to the prize and/or to the contest.
- 39. The Sponsor is not entering into any contractual, legal or any other kind of relationship with itself and the participants or between participants in running this contest.

Any dispute, issue or other matter arising with reference to the Participant's participation in the contest and/or the contest or any related matters thereto shall be referred to Arbitration under a sole Arbitrator appointed by the Sponsor. The said Arbitration proceedings shall be governed by the Arbitration and Conciliation Act, 1996, as amended from time to time. The venue for arbitration shall be Mumbai and proceedings shall be conducted in English language. All the costs, charges and expenses in connection to the Arbitration shall be solely borne by the person who has raised the dispute.
- 43. Courts in Mumbai shall have exclusive jurisdiction over all matters relating to participation in the contestant/or the contest. Subject to the provision of rule 24 above, the courts having jurisdiction under the provisions of the Arbitration and Conciliation Act, 1996, to determine all matters which the court is entitled to determine under the Act, including, without limitation, provision of interim relief's under the provisions of Section 9 of the Arbitration and Conciliation Act, 1996, shall exclusively be the courts at Mumbai, India.
